

FUNDAMENTALS OF SITE CONTAMINATION 2-DAY TRAINING PROGRAM 2024

This training program will cover fundamental steps in the environmental site assessment process, in accordance with current industry practice, guidelines and standards, as well as the basics of site remediation.

The program includes theory, practice and case studies presented throughout the 2-day course. Presenters include industry experts (geologists, hydrogeologists, risk assessors, remediation experts and contaminated site auditors) as well as the regulator (SA EPA).

The case studies will be based on example sites in South Australia, with regard to current SA legislation and guidelines as well as the *National Environment Protection (Assessment of Site Contamination) Measure 1999*.
